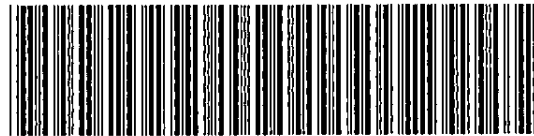

1. NAME.

The name of the Limited Liability Company is Zingales, LLC (hereinafter referred to as the "Company").


2. MAILING ADDRESS AND STREET ADDRESS OF PRINCIPAL OFFICE.


