**ARTICLE I
NAME**

The name of the limited liability company filing these Articles of Dissolution is DMG Sunrise, LLC.

ORIGINALLY FILED ARTICLES**

The Articles of Organization of DMG Sunrise, LLC. ("Company") were filed on August 3, 2010.

**ARTICLE III
APPROVAL OF DISSOLUTION**

The Manager and Member of the Company held a special meeting on the 15th day of July, 2017 at which the sole Member and the sole Manager of the Company were present. At the meeting, it was determined that it was in the best interest of the Company to dissolve and for the assets of the Company to be liquidated in accordance with the Plan of Dissolution presented and approved by the Member at the meeting. Under the Plan of Dissolution which conforms to the relevant provisions of the Operating Agreement, the net assets of the Company after the collection and allocation income and the payment of creditors shall be distributed to the Member during the winding up period. No continuing operations of the Company will occur following the Effective Date, defined below.

The Dissolution of the Company was approved on the 15th day of July, 2017 by the sole member, which according to Section 6.1.1 of the Company's Operating Agreement was sufficient for passage of Articles of Dissolution and Plan of Dissolution.

The effective date for the Dissolution is 15th day of July, 2017 ("Effective Date").

**ARTICLE IV
PROVISION FOR LIABILITIES**

The Company has no liabilities other than liabilities incurred in the ordinary course of business as of the approval date and no liabilities will be incurred prior to the Effective Date. There are no suits pending against the Company in any court.
