**ARTICLES OF ORGANIZATION OF
ELLSLEY SOBOL, P.L.**

The undersigned, for the purposes of forming a professional limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, as amended, and the Professional Services Corporation and Limited Liability Company Act, Florida Statutes Chapter 621, as amended, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I – NAME

The name of the professional limited liability company is Ellsley Sobol, P.L. (the "Company").

ARTICLE II – ADDRESS

The principal office of the Company is 111 N. Pine Island Road, #103, Plantation, FL 33324. The mailing address of the Company is 111 N. Pine Island Road, #103, Plantation, FL 33324.

ARTICLE V – NATURE OF BUSINESS

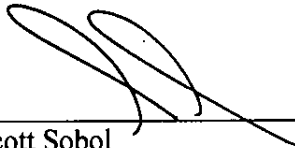
The general nature of the business to be transacted by the Company shall be to engage in every aspect of the practice of law. The Company shall not engage in any business other than the profession of law; provided, however, that the Company may invest its funds in real estate, mortgages, stock, bonds or other types of investments and may own real and personal property necessary for the rendering of the professional services authorized hereby.

ARTICLE VI – RESTRICTION ON ISSUANCE AND TRANSFER OF OWNERSHIP

No person shall be admitted as a member of the Company unless such person is a professional corporation, a professional limited liability company, or an individual, each of which must be duly licensed or otherwise authorized to practice law in the State of Florida. No member of the Company shall enter into any agreement vesting another person with the authority to exercise any of that member's voting power in the Company. No member of the Company may sell or transfer ownership interest in the Company except to another professional corporation, professional limited liability company, or individual, each of which must be eligible to be a member of the Company.
