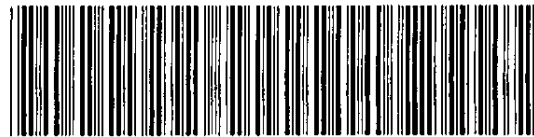

The name of the Limited Liability Company is **GM 601, LLC** (the "Company").


ARTICLE II - Address
