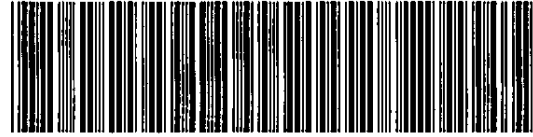

**AMENDED AND RESTATED ARTICLES OF ORGANIZATION**

The undersigned hereby submits these Amended and Restated Articles of Organization for the purpose of forming a limited liability company under the laws of the State of Florida.

1. The name of the limited liability company is LI'L J'S COUNTRY BUFFET, LLC.

7. The limited liability company is to be managed by the members and the name and address of the managing member who is to serve until the first annual meeting is as follows:

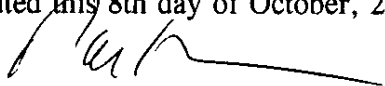



As used herein, the term "improper personal benefit" does not include a manager's reasonable compensation or other reasonable incidental benefit for or on account of his service as a manager, employee, independent contractor, attorney or consultant of the limited liability company. No amendment or repeal of this article, nor the adoption of any provision to these Articles of Organization inconsistent with this article, shall eliminate or reduce the protection granted herein with respect to any matter that occurred prior to such amendment, repeal or adoption.
