DISTRIBUTION OF EARNINGS**

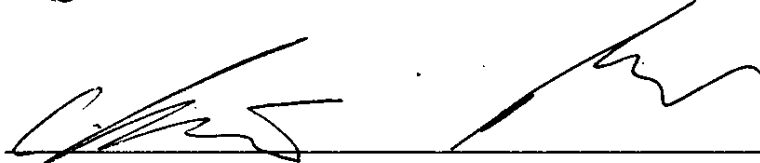
The members of the Company shall have the sole discretion whether to issue earnings to
