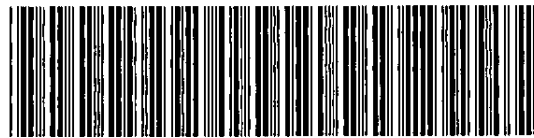

**ARTICLE I.

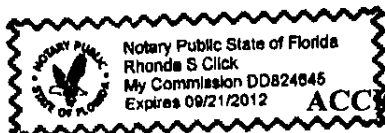


