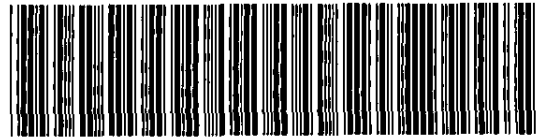

The Company may admit any additional members as set forth in the operating agreement for the company upon the member becoming a party to the operating agreement.


ARTICLE 10: AMENDMENT

ARTICLE 11: CERTIFICATES


