The name and street address of the registered agent of the company in the State of Florida is David Glenn Green, 5754 Rolling Hills Drive, Milton, Florida 32570.

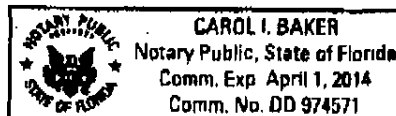
ARTICLE V - MANAGEMENT

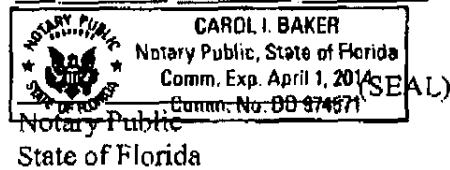
