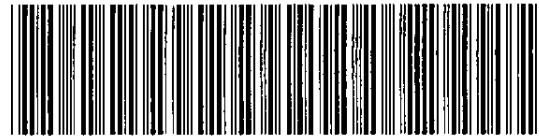

The undersigned individual hereby organizes and forms a limited liability company under and pursuant to Chapter 608, Florida Statutes as follows:

ARTICLE 1.

Name of Limited Liability Company

The name of this limited liability company ("Company") shall be ESTEIN TRANSITION, LLC.

ARTICLE 2.

Period of Duration

This Company shall be in existence for a period of forty years six months from the date of filing these Articles with the Department of State unless sooner terminated by vote of the members.
