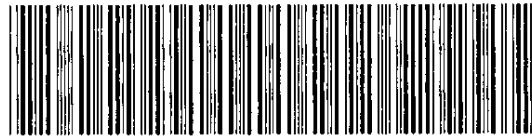

B. This Amendment is submitted to:


