TO
ARTICLES OF ORGANIZATION

Pursuant to Florida Statutes Section 605.0202, the Articles of Organization of AMBASSADOR HEALTH SOLUTIONS, LLC filed on August 11, 2010 and assigned Document Number L10000084049, as subsequently modified by Articles of Amendment to Articles of Organization filed on January 18, 2018, are hereby amended as follows:

1. Article VI is hereby deleted and replaced with the following:

ARTICLE VI. MANAGEMENT

The Company shall be managed by one (1) manager (the "Manager") and is, therefore, a manager-managed limited liability company. The identity of the Manager and the rights, duties, obligations and authority of the Manager shall be as set forth in the Operating Agreement of the Company.

2. Except as specifically amended herein, all terms, provisions and conditions of the Articles of Organization, as amended, shall remain unmodified, and otherwise in full force and effect.


