ARTICLE II - Address

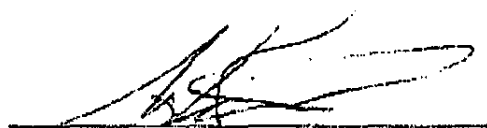
