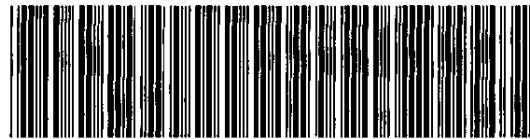





- (6) Effective Date. The effective date of these Articles of Organization shall be the date of filing of the Articles of Organization with the Secretary of State of the State of Florida.


