#### AMENDED ARTICLES OF ORGANIZATION

#### **OF**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Amended Articles of Organization. The original article were filed on August 16, 2010 Doc. No. L10000085496 however they failed to include the correct registered agent and the information contained in Articles VI through Article X herein.

#### **ARTICLE I -- NAME**

The name of the limited liability company shall be HAK HIDE, LLC.

#### ARTICLE II -- ADDRESS

#### ARTICLE III - PURPOSE

The limited liability company is organized to operate for any lawful purpose.
