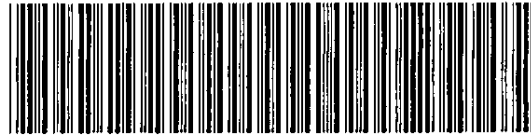

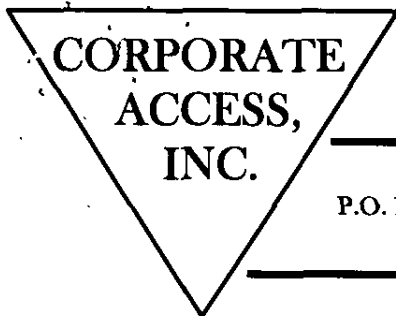


**ARTICLE IV – MANAGEMENT:**
