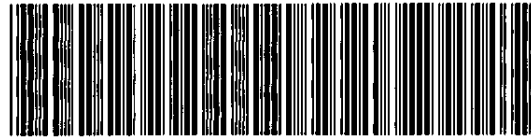

**ARTICLES OF ORGANIZATION  
OF  
ANASTASIA LAW, P.L.**

The undersigned, desiring to form a professional limited liability company under and pursuant to Chapters 608 and 621, Florida Statutes, entitled the Florida Limited Liability Company Act and the Professional Service Corporation and Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company:

1. **NAME.** The name of the company shall be Anastasia Law, P.L. ("company").
2. **DURATION/CONTINUATION.** The period of this company's duration shall be perpetual, unless terminated by the unanimous written agreement of the members. In the event of the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member, the business of the company may be continued by the unanimous consent of the remaining members.
3. **PURPOSES.** This corporation is organized for the following purposes:
  - a. To engage in the practice of law as a professional law corporation and to carry on services incident to the practice of law, and
  - b. To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation, and
  - c. To engage in any activities or business permitted for this company under the laws of the State of Florida.

The professional legal services of this corporation shall be carried out only through officers, employees, and agents, each of whom has been admitted to the bar of, and is duly authorized to practice law in, the State of Florida.




