**ARTICLES OF ORGANIZATION  
OF  
RAS PARTNERS, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I**

**NAME**

The name of the limited liability company shall be RAS Partners, LLC (the "Company"). The mailing address and street address of the Company shall be 917 1<sup>st</sup> Street South, #202, Jacksonville Beach, Florida 32082.

**ARTICLE II**

**PURPOSES AND POWERS**

The Company shall not be dissolved upon the occurrence of any event that terminates the continued membership of a member in the Company, provided there is at least one remaining member. The Company shall be terminated and dissolved upon the consent of all of the members.


**ARTICLE VI****MANAGER**
