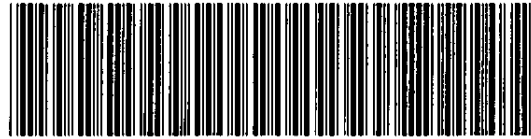

ARTICLES OF ORGANIZATION

Of

FLORIDA IONIC GREEN SOLUTION, LLC.

ARTICLE I

Name and Duration

The name of this Limited Liability Company is, FLORIDA IONIC GREEN SOLUTION, LLC. (hereinafter referred to as the "Company"). The duration of the Company shall commence upon the filing of these Articles of Organization and shall be perpetual.

Admission of Additional Members


