

PAIRINGS BEER WINE TAPAS, LIMITED LIABILITY COMPANY

The undersigned, for purposes of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statute Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be **Pairings Beer Wine Tapas, Limited Liability Company** (L.C./L.L.C./LC/LLC) (from hereinafter referred to as “The Company”).

ARTICLE II – ADDRESS

The mailing address and street address of the principal office of the Company is 773 Peppervine Avenue, Jacksonville, Florida, 32259.


ARTICLE III – DURATION

The Company shall commence its existence on the date these Articles of Organization are filed with the Florida Department of State or on another effective date if specified. The Company’s existence shall be perpetual unless the company is dissolved earlier as provided in these Articles of Organization or in the regulations.

ARTICLE IV – REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the Company in the State of Florida is Daniel M. Copeland, Esquire, at 9310 Old Kings Road South, Suite 1501, Jacksonville, Florida 32257.

Having been named as registered agent and to accept service of process for the above stated limited liability company at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided for in Chapter 608, Florida Statutes.

ARTICLE V – MEMBER’S RIGHT TO CONTINUE BUSINESS

The Company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or in the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the Company is continued by a majority vote of the remaining members.

ARTICLE VI – OWNERSHIP

Ownership of the Company shall be as follows: **Polly Anne Lynch**, as majority owner, shall hold a 51% ownership interest; and **Jay Lynch**, as minority owner, shall hold a 49% ownership interest.

ARTICLE VII – MANAGEMENT

The Limited Liability Company is to be managed by the two originating Members and is, therefore, a Member-managed company. This agreement shall be done in accordance with regulations adopted by the members for the management of the business affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. 


