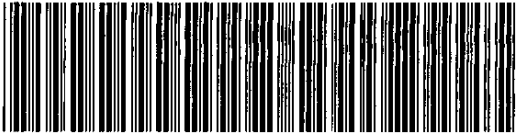


Good day,
