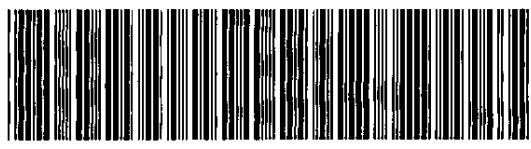

Pursuant to the Florida Limited Liability Company Act, Florida Statutes, 608.407 (2002), as amended from time to time (the "Act"), the following are adopted as the Articles of Organization of the limited liability company organized hereby:

**ARTICLE I.
NAME**

The name of this limited liability company (the "Company") shall be STOCKHOLM, LLC.

**ARTICLE II
DURATION**

Unless earlier terminated pursuant to the Act or the regulations (as defined in §608.407 of the Act) of this Company, the period of its duration shall be perpetual.

**ARTICLE III
ADDRESS**

**ARTICLE IV
REGISTERED AGENT**

ADDITIONAL MEMBERS**

Pursuant to §608.407, Florida Statutes, additional members may be admitted upon the approval by the then current members owning more than fifty-one percent (51%) of the membership interests.

**ARTICLE VI
CONTINUATION OF BUSINESS**

Pursuant to §608.407, Florida Statutes, the remaining member of this Company shall have the right to continue the Company's business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of the member in this Company.


**ARTICLE VII
