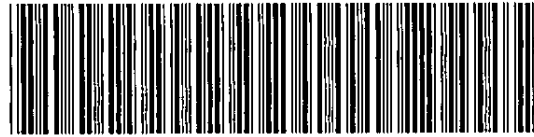

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

ARTICLE I - NAME

The name of this Limited Liability Company is JEREMIAH 2911 AT REW CIRCLE, LLC.

ARTICLE II - MAILING ADDRESS

The mailing address and street address of the principal office of JEREMIAH 2911 AT REW CIRCLE, LLC, is 9780 Wild Oak Drive, Windermere, FL 34786.

ARTICLE III - DURATION
