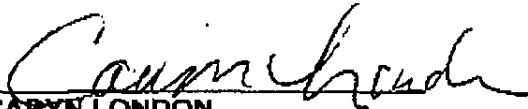
**ARTICLE VI - RIGHT OF REMAINING MEMBERS TO CONTINUE BUSINESS**
