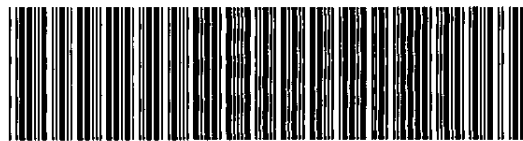

This limited liability company shall have a perpetual existence.


