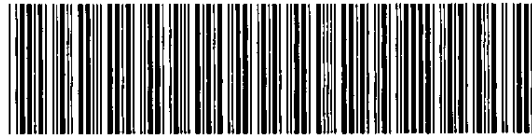

The name of the Company shall be Built Investors, LLC.


