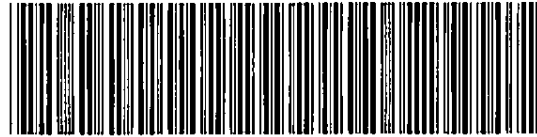

To whom it may concern:

This letter is written to detail the sequence of events for the fraudulent voluntary dissolution of Happy Stars Academy, LLC. When Happy Stars Academy, LLC was formed it was jointly managed by husband and wife, Yuliya A. Golikova and Vadim A. Valenteychik.

Pursuant to the divorce decree, Case No. 2024 DR 000860 Circuit Court Flagler County, Mr. Valenteychik was divested of any ownership interest in the company, Ms. Golikova received full ownership and custody of Happy Stars Academy LLC. Legal steps were taken to put the state and public on notice that Mr. Valenteychik's authorization within that company was removed.

As of that date Mr. Valenteychik could not legally act as an authorized person for Happy Stars Academy, LLC.

On or about December 6, 2024, Mr. Valenteychik filed a fraudulent Article of Dissolution with the Secretary of State to dissolve the Happy Stars Academy, LLC. Mr. Valenteychik used an electronic signature posing as an authorized user of Happy Stars Academy, LLC. This information was false and was in violation of section 817.155 of Florida statute.

Ms. Golikova has and continues to operate Happy Stars Academy, LLC. The company is not dissolved or inactive, and a revocation of article of dissolution will be filed with the secretary of state.


