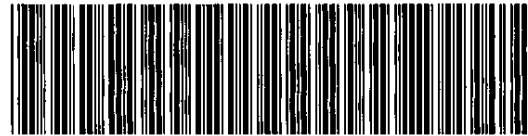



ARTICLES OF ORGANIZATION

ARTICLE I: NAME OF COMPANY
