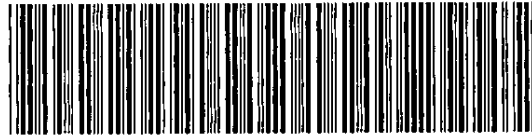

The undersigned, pursuant to the provisions of Chapter 608, Florida Statutes, provides the following information for the purpose of amending the Articles of Organization of **PINE TREE LAKE, LLC**, which was formed under the laws of the State of Florida pursuant to Articles of Organization originally filed with the Department of State on August 25, 2010, and assigned document number L0000089473.

1. Article 1 of the Articles of Organization is amended to read:

**ARTICLE 1.  
Name**
