MANAGEMENT

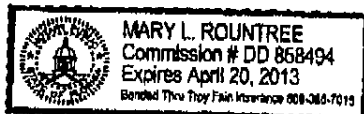


