**ARTICLE I - NAME**

## ARTICLE VI - MEMBERS RIGHT TO CONTINUE BUSINESS

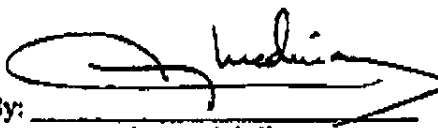

## ARTICLE VII - MANAGEMENT

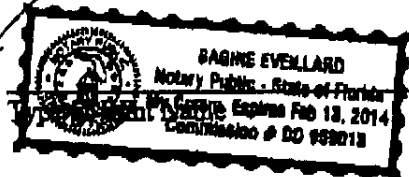

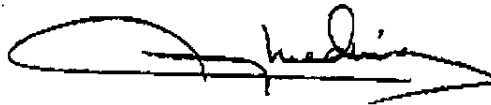
