

5. To do such other acts as are incidental to the foregoing or desirable in order to accomplish the purpose for which the company was formed;

6. To have and exercise all rights and powers that are now or may hereafter be granted to a limited liability company by law.

B. The foregoing shall be construed as objects, purposes, and powers, and enumeration thereof shall not be held to limit or restrict in any manner, the powers hereafter conferred on this limited liability company by the laws of the State of Florida.

C. The Company may, in its operating agreement, confer powers, not in conflict with law, or its managers and member in addition to the foregoing and in addition to the powers and authorities expressly conferred on them by statute.


