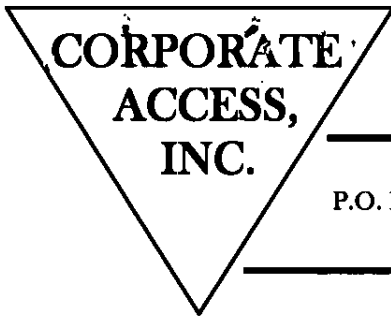

ARTICLE III - MANAGEMENT




ARTICLE IV

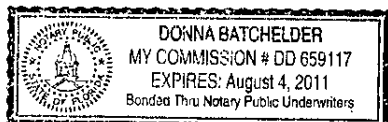
