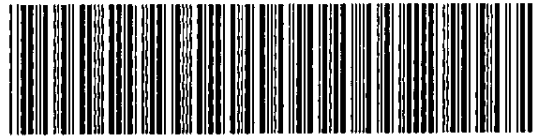

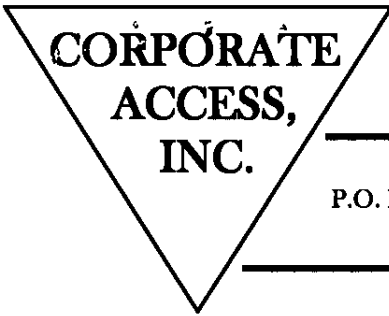

ARTICLE III - MANAGEMENT


