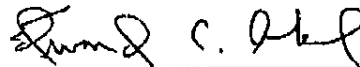

The Company shall be effective August 23, 2010 and shall have perpetual duration.

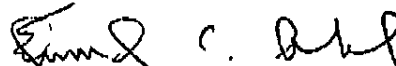
