ARTICLE 1 - NAME

The name of the limited liability company shall be **MK MARSH LLC** ("Company").

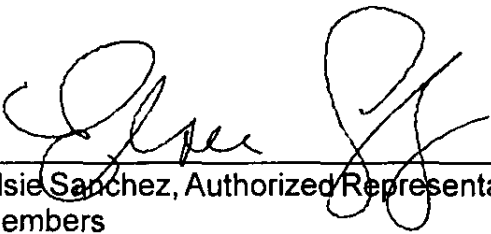
