**Articles of Organization  
of  
EOvation Advisors LLC**

(A Florida Limited Liability Company)

The undersigned organizer hereby adopts these Articles of Organization for the purpose of forming a Limited Liability Company under The Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes (the "Act").

1. **NAME**. The name of this limited liability company (the "Company") is EOvation Advisors LLC.

2. **EFFECTIVE DATE AND DURATION**. The existence of the Company shall commence on September 1, 2010. The period of duration of the Company shall be perpetual.




