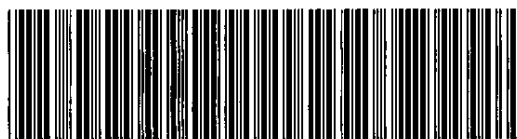





**Members Rights to Continue Business**



