ARTICLES OF ORGANIZATION AMERICAN LANDSCAPE AND LAWN NORTH, LLC A FLORIDA LIMITED LIABLITY COMPANY (FS §608.401)

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute 608 entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company:

- 1. Name. The name of this company shall be American Landscape and Lawn North, LLC. The mailing address and street address of the principal office of the LLC is as follows: 1868 Wildcat Cove, Fort Pierce, FL 34949.
- 2. Duration/Continuation. The period of this company's duration shall be 99 years, unless terminated by the unanimous written agreement of all members or by the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminates the continued membership or a member, unless the business of the company is continued by the consent of all the remaining members, or by amendment of these Articles of Organization providing for the continued existence of the company subsequent to the foregoing events.
- 3. Purposes. The purposes for which this company is being formed are the following:
 - a. To engage in any activities for business permitted for this company inder the laws in the State of Florida.
- 4. Registered Agent and Office. The name and address of the initial register agent and office for this company are as follows: JAMES B. SULLIVAN, SR., 1868 Wildcat Cove, Fort Pierce, FL 34949.
- 5. Admission of Additional Members; and Terms and Conditions of such Admissions: Additional Members may be admitted upon the approval of a majority of the Members of the Company, upon the written application for such new Member, in the manner set forth in the Bylaws of this Company.
- 6. Management of Company. The business of the Company shall be managed by a Manager or Managers who shall be elected annually by the Members of the company in the manner prescribed by and provided in the regulations of the company. Such Manager or Managers shall also hold the offices and have the responsibilities accorded to them by the Members and more particularly described in the Operating Agreement entered into between the Members of such Manager(s).
