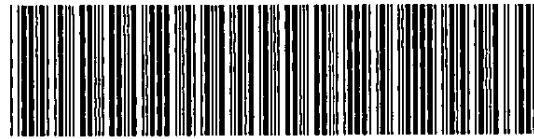

All debts, obligations and liabilities of the Company have been paid or discharged.


The net assets of the Company remaining after the dissolution were distributed to the sole Member.
