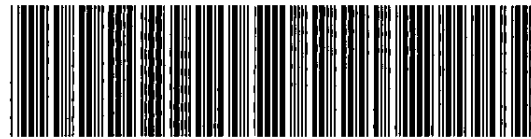

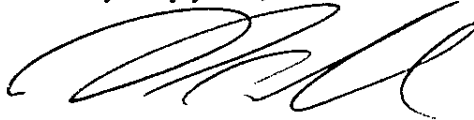

## **ARTICLES OF ORGANIZATION**

**OF**

### **AUDIOLOGY CONSULTANTS OF SOUTHWEST FLORIDA, PL**

The undersigned, incorporator of Audiology Consultants of Southwest Florida, PL, a Florida Professional Limited Liability Company (the "Company"), hereby forms a Professional Limited Liability Company under the laws of the State of Florida.

#### **ARTICLE I** **COMPANY NAME**

The name of this Company is: **Audiology Consultants of Southwest Florida, PL**

#### **ARTICLE II** **COMMENCEMENT AND TERM OF EXISTENCE**

In accordance with the Florida Statutes Chapter 621, Florida Limited Liability Company Act (the "Act"), the term of existence of the Company shall commence upon the filing of these executed Articles of Organization with the Florida Department of State, and shall continue perpetually, unless otherwise dissolved pursuant to Article XII of these Articles of Organization.

#### **ARTICLE III** **PURPOSES AND POWER**

In addition to the powers authorized by the laws of the State of Florida for Professional Limited Liability Companies under the Act, the general nature of the business or businesses to be transacted, and which the professional limited liability company is authorized to transact, shall be to engage of every phase and aspect of the business of rendering professional audiology testing, care, treatment, and services incidental thereto.

**ARTICLE VI**  
**MEMBERSHIP AND ADMISSION OF ADDITIONAL MEMBERS**

All members of this company shall be licensed in the State of Florida as an Audiologist. Pursuant to the Act, the Company may admit additional audiologist members upon the affirmative vote of the holders of not less than ninety percent (90.00%) of the Shares in the Company in attendance at a duly called meeting of the members of the Company at which a quorum exists or by written consent of the holders of not less than ninety percent (90.00%) of the Shares in the Company. Any new member which is approved by the members of the Company as set forth herein shall become a member of the Company upon payment of the contribution to the capital of the Company as established from time to time by the members of the Company, and upon such member's agreement to comply with these Articles of Organization, the Regulations and such other documents, statutes, rules, regulations or guidelines as the members of the Company may from time to time determine in their sole discretion.

**ARTICLE VII**  
**DISSOLUTION OF COMPANY**

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the Company shall be dissolved unless the other members elect to continue the Company either upon the affirmative vote of the holders of not less than ninety percent (90.00%) of the Shares in the Company, which vote is taken at a duly called meeting of the members of the Company or by written consent of the holders of not less than ninety percent (90.00%) of the Shares in the Company, and so long as there remains not less than one (1) member of the Company.

**ARTICLE VIII**  
**MANAGER**

The Company shall be managed by one manager. The name and address of the initial manager is set forth below. The initial manager shall serve until the first annual meeting of the members of the Company or until his successors are elected and qualify.

**ARTICLE IX**  
**AMENDMENT TO ARTICLES OF ORGANIZATION**

Members may adopt, alter, amend or repeal any provision of the Articles of Organization upon the affirmative vote of the holders of not less than ninety percent (90.00%) of the Shares in the Company which vote is taken at a duly called meeting of the members of the Company or by written consent of the holders of not less than ninety percent (90.00%) of the Shares in the Company.
