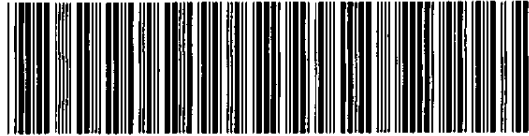

6. There are no suits pending against the limited liability company.

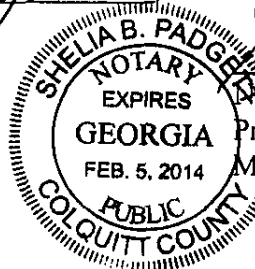
