

## Articles of Organization of Inglewood Avenue, LLC A Florida Limited Liability Company

The undersigned as a member of the company files these Articles of Organization to form a Florida Limited Liability Company (the "company") under the Florida Limited Liability Company Act (Chapter 608, Florida Statutes).


