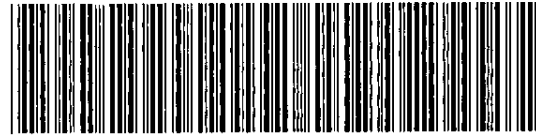


#### **ARTICLE V – GOVERNED BY OPERATING AGREEMENT**
