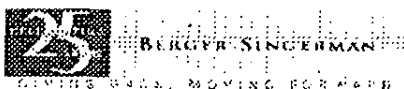


Article 1 of the Company's Articles of Organization is hereby amended by deleting it in its entirety and inserting a new Article 1 to read as follows:
