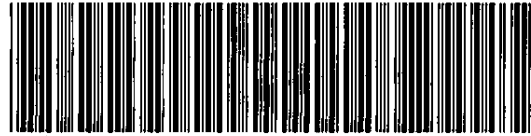

Article III - Duration





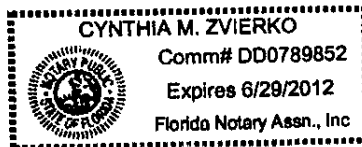
