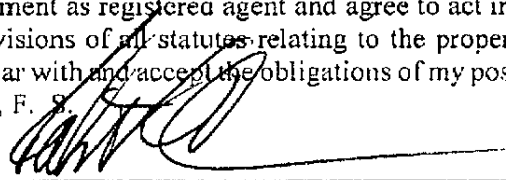

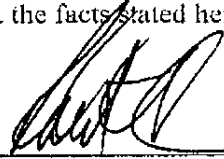
ARTICLE IV
