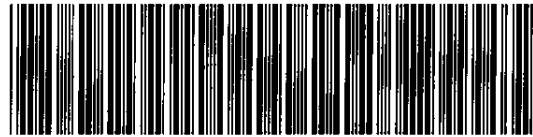



The admission of members and their capital contributions shall be governed by the operating agreement.



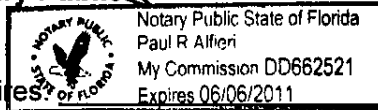
