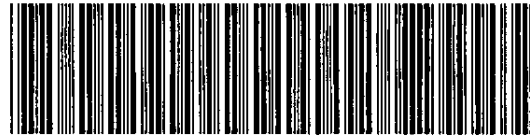




Pursuant to Section 608.411, Florida Statutes, the Articles of Organization of the above named Limited Liability Company are amended as follows:
