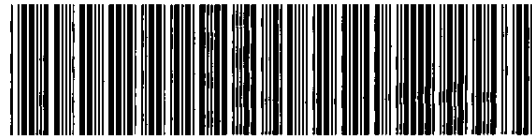

ARTICLES OF ORGANIZATION

OF


ARTICLE VII.
